

## **Privacy Policy**

This Privacy Policy was updated on September 20, 2018.

Since your privacy is important to Junglee Coupon, we have created a Privacy Policy detailing how we collect, use, disclose, transfer, and store your information.

### **Collection and Use of Personal Information**

Personal information i.e. data that can be used to identify or contact a person.

In the event you contact Junglee Coupon for support, you may be asked to provide your personal information. Junglee Coupon may use your personal information consistent with this Privacy Policy. It may be combined with other information to improve our products and services. You are not required to provide us any personal information. However, if you elect not to, we may not be able to respond to your questions or provide you with the support or services you requested.

Here are some examples of the types of personal information Junglee Coupon may collect and how we may use it.

#### **What personal information we collect**

When you create a Sign In ID or contact us, we may collect a variety of information including your name, email address, and/or phone number.

#### **How we use your personal information**

We may use your personal information to reach back out to you after looking into an issue you have raised.

We may also use your personal information to inform you about app updates and upcoming events.

If we ever combine personal information with non-personal information the combined information will be treated as personal information.

#### **Disclosure to Third Parties**

Junglee Coupon may pass on certain personal information to strategic partners to improve your customer experience. For example, if you have an issue with you app, we may pass your personal information to a strategic partner to help you resolve the issue. Personal information will not be shared with third parties for their marketing purposes.

#### **Service Providers**

Junglee Coupon shares personal information with companies who help to generate and fulfill customer orders, provide customer service, and ensure overall customer satisfaction. These companies are obligated to protect your information in accordance with this Privacy Policy.

## **Others**

If required by law, legal process, litigation, and/or requests from public and governmental authorities within or outside your country of residence, Jungleee Coupon may disclose your personal information if necessary or appropriate.

We may also disclose information about you if required to protect our operations or users. In the event of a sale, merger, or reorganization we may transfer any and all personal information we collect to the relevant third party.

## **Children**

We take extra precautions to protect the safety and privacy of children using Jungleee Coupon products and services. Accordingly, we do not knowingly collect, use or disclose personal information from children under 13, without verifiable parental consent. If we learn that we have collected the personal information of a child under 13, or equivalent minimum age depending on jurisdiction, without first receiving verifiable parental consent we will take steps to delete the information as soon as possible.

## **Third-Party Sites and Services**

The Jungleee Coupon app displays coupons being offered by third party merchants. Any information collected by these third party merchants, is governed by their privacy practices. We encourage you to learn about the privacy practices of those third party merchants.
